

What is the BC Rural Health Network?

The BC Rural Health Network (BCRHN) is a not-for-profit society and CRA registered charity, that leads initiatives to improve healthcare in rural and remote communities across British Columbia by employing community-driven solutions and advocacy rooted in solid science. Confronting challenges exacerbated by the COVID-19 pandemic and a growing disconnect between rural residents and their healthcare systems, the BCRHN champions communication and solution-sharing among rural communities, recognizing that although communities are unique, there is pan-provincial applicability of local, successful health strategies.

The Network consists of over 120 health related organizations: non-profits, municipalities, regional districts and individuals working in cooperation with healthcare policymakers. The purpose of the Network is to promote and support a health services system that improves and sustains the health and well-being of residents of rural communities across British Columbia. The BC Rural Health Network is apolitical, nonpartisan and solutions based.

- 1. Offer access to resources on rural well-being.
- 2. Offer access to reliable rural health news and information.
- 3. Record and share community experiences.
- 4. Present research-backed positions and solutions that are driven by rural communities.
- 5. Support system changes that help create equity in access to care and better health for all rural BC residents.

- 6. Share successful strategies to address rural healthcare concerns.
- 7. Advocate for policy changes that provide all rural residents with attachment to a health care practitioner.
- 8. Identify areas of research aimed at improving access to healthcare in rural communities and to provide fertile ground for research to take place.
- 9. Inform the BC Ministry of Health of rural healthcare concerns.
- 10. Recommend solutions for the improvement of services to rural BC residents.
- 11. Work in partnership with other provincial organizations to influence policy changes that improve access to healthcare services.
- 12. Recognize the healthcare concerns of indigenous communities and include their issues and concerns as part of our work.
- 13. Improve access to mental health services.
- 14. Promote patient-centred, community-based primary healthcare reform.

How we work:

Solutions based: we represent solutions that our membership agrees upon and don't represent people or organizations.

Evidence based: we work with research teams to validate our beliefs and to provide evidence of our positions.


Driven by lived experience: we believe that qualitative data and the lived experiences of communities and their residents is often missed in developing health policy and procedures for rural communities. We seek the lived experience of individuals from across BC, we record and share these experiences.

Rural governance: we have a governance board that consists of a diverse group of rural community champions whose lived experience is from rural BC.

Inclusive and diverse: our team of directors, liaisons, and staff are from all walks of life, from all political perspectives, are all rural residents and represent a diverse and inclusive team. We seek to expand our diversity and include as many differing opinions as we can attract.
